SEVENTH QUERY FROM OVYM BOOK OF DISCIPLINE:



FOR SEASONED FRIENDS WILLING TO SERVE AS NURTURERS/MENTORS – EXPERIENCE, EDUCATION, SPECIAL INTERESTS:

These lines of the poet Kabir seem relevant here: “The words Guru, Swami, Super Swami, Master, Murshid, Yogi, Priest, most of those sporting such a title are just peacocks. The litmus test is: hold them upside down over a cliff for a few hours. If they don’t wet their pants, maybe you found a real one.”

I was once one of those peacocks, having served as a priest for nine years. I have spent much of my life since then trying to center my life on the truth of human equality. I have been a Quaker for 20 years, and apart from my marriage, Quakerism has served as the greatest equalizer in my spiritual journey. I maintain a great respect for the Catholic tradition,--particularly its mystical tradition-- but have found a home among Friends. My religious orientation is contemplative, but I have never come close to being what Kabir called “a real one.” I tend to get de-centered at far less than being hung upside down over a cliff for a few hours.

I have been a professor of education for 38 years, and have learned that listening is crucial to working with students. So, though I am in no way “a real one” in Kabir’s sense, I am able to listen and share, and facilitate meaningful insights through conversation from time to time.

**OUR FINANCES
WALKING THE TALK**

Even in these very difficult financial times, we can be thankful for responsible stewardship last year. From June 2007 to December 2009 we as a Meeting have acted responsibly both in long range planning and shorter term goals. In the long term goals we held a capital campaign which raised over \$68, 0000.00. These funds allowed us to both save money and support environmentally responsible changes by installing a zoned furnace and replacing all of the solarium windows. These green retrofitting projects came from the recommendations made to our Friends in Unity with Nature (FUN) Committee during the energy audit conducted by Jim Tenhunfeldt over a decade ago and supported by our House and Grounds Committee.

We also have been able to pay all of our recommended contributions to wider Quaker bodies and charitable organizations at the level of over \$3,000.00.

Can we actually expect that budgeted contributions will appear by year's end, as has sometimes happened in the past . . . and sometimes not? If you are someone who is not likely to make a significant contribution late this year, please consider what you could do sooner or on a monthly basis.

Summary of Meeting for Worship with Attention to Business
Sixth Month 13, 2010

19 in attendance for Monthly Meeting for Business, with Doug Burks clerking. No meeting with attention to business was held in May because of Mother's Day.

Clerks report-Doug Burks reporting: More items are being posted to the website, including the agenda and certain committee reports. The process towards the website instead of emailing is in transition. Eventually, it will only be posted to the website. Caution against posting names and phone numbers on the website was reiterated.

1. Action Items

Memorial minute for Ed McAndrews was read by Eileen Bagus. She noted that it was largely, thoughtfully and beautifully written by Eric Wolff. Because he was not a member at the time of his death, the minute is for our meeting only and will not be distributed to other meetings. Minute approved.

Request for Youth Membership for Charlotte Dean, reported by Ministry and Counsel by Eileen Bagus. Membership approved.

Nominating Committee, Mary Anne Curtiss reporting. Of note was that House & Grounds has a startlingly few full members, and a request was made for additional full members. The Presiding Clerk's term was discussed. Eileen Bagus accepted the position of Asst. Presiding clerk, which is traditionally a four year commitment, including a first year as asst. clerk, two years as presiding clerk, and a fourth year as asst. clerk. The only correction was to note that the OVYM executive committee appointments carry a two year term. Suggestions were made for possible additions to House & Grounds. It was noted that in June, both incoming and outgoing committee members meet together to transfer information. In July, the new committee meets on its own. It was noted that many of the teens are active on various committees. Jennifer Snow Wolff noted that she is available for help on any committee over the next year before she formally moves to Cincinnati. Nominating Committee slate was approved with gratitude. Doug noted that the convener calls the first meeting. Doug charged the conveners to call the first meeting of the committee within the next few weeks, inviting both past and new committee members.

Report from Building and Grounds; FUN and Stewardship on Windows, reported by John Sniegocki. There is a possibility of getting the windows at $\frac{1}{2}$ the original anticipated costs, which would mean we could do twice as many windows, using the remaining capital campaign funds, and doing a smaller scale capital campaign to try to get a few more of the windows done. Rich House proposed that he could get the windows directly, reducing the cost, and we could use an installer recommended by Sarah Hoffman. Instead of doing 2-4, we would be able to do 4-8 windows. Energy efficiency is a high priority for the meeting. We would like to have triple pane windows which are twice as energy efficient than double pane windows. Mary Anne Curtiss expressed some concern about asking for more funds from members at this time of year because money is

already tight during the summer. Marjorie Isaacs noted that she spoke to someone who has the same windows we are considering, and he was very enthusiastic about the windows. A discussion ensued regarding which windows would be replaced and who would steward the additional capital campaign. Mary Anne noted that if we spent the larger amount suggested, a potential problem might exist in that some of our funds are tied up in 4 year CDs. John requested that a decision be made as to who decides which windows get replaced when, in order to expedite the process. Doug requested the meeting to approve the expenditure of up to and not to exceed the remaining funds pledged or received in the capital campaign to replace as many windows as those funds allow, and that house and grounds decide which windows would be replaced. Approved. A second proposal for approval was made by Doug to try to raise an amount not to exceed \$3,900 to do the other windows suggested. Stewardship and House & Grounds will jointly oversee the second phase of fundraising. Proposal approved.

Discussion from Miami Quarterly Meeting to discontinue permanently the second month Quarterly Meeting. Weather, attendance, and travel issues were behind this change. Only fifth month and tenth month meetings would be held if this change is approved. Bill Cahalan shared his experiences as our representative to Miami Quarterly Meeting. He was leaning towards approving it temporarily, rather than permanently. Eugenia Mills expressed some concern that Miami Quarterly meetings were necessary at all. Eric Wolff thought that the meetings should be changed to a purely social function to encourage attendance. Other members shared similar thoughts, concurring that yearly meetings served an important function, but that the quarterly meetings were not as meaningful. Concern that meetings on Sunday had a dilutive effect because of commitments to members' own meetings was also expressed, with Saturday meetings being an option. A desire for clarity of what quarterly meetings really provide was expressed. Comments sent to Ben reflecting the diversity of our members' thoughts was recommended.

2. Committee reports

- Treasurer-Mary Anne Curtiss reporting, noting that the general fund is disastrously low, the bank balance to budget ratio is only 3%. It would be even worse if we had not stopped payments to our wider Quaker responsibilities. The financial position has improved since the beginning of the month, however, because as the need was expressed, so raise the financial response of our members. Mary Anne noted that we now have the funds available to catch up our OVYM commitment, but it would require a leap of faith that other funds would avail themselves to help us get through the summer. There are not enough funds to catch up FGC. Eugenia Mills expressed appreciation to our very enthusiastic and responsible treasurer, a sentiment shared by all of us. Treasurer's report accepted, and approval was received to pay off our OVYM commitment.

- FUN-Bill Cahalan reporting. Local food initiatives are making progress. Carry ins will continue during the summer, on the fourth Sunday of June, third Sundays of July and August, hopefully using more local ingredients in our dishes. Outdoor worship is still hoped for in June, July and August. The bees are progressing as usual. It is hoped that the queen is in our hive and the storage of honey is occurring. Bees are an indicator species as to the health of our environment. Bill read a note he received from Karen Arnett regarding the issue of signage by the beehive. It was suggested that a positive Bee sign be posted. Jennifer volunteered to assist with the artwork.
- House and Grounds-Eric Wolff reporting, we did not qualify for the energy efficiency grant because like most churches, we may or may not be a registered 501 (c) (3). A discussion ensued as to whether or not this status should be pursued for future opportunities.
- Ministry and Council-Eileen Bagus reporting, youth membership requested by Lucas Bertaux-Skerik. Also, follow up is being done from the retreat earlier this spring for spiritual nurturers. They would like to feature one nurturer a month in the Community Companion. If ministry & council, who is Lisa Cayard, although that information will change with the new committee year.

What is FCNL?

The Friends Committee on National Legislation is a Quaker lobby in the public interest. FCNL is the oldest registered religious lobby in Washington. FCNL staff and volunteers work with a nationwide network of tens of thousands of people from many different races, religions and cultures to advocate for social and economic justice, peace, and protection of the earth.

Their mission statement reads:

We seek a world free of war and the threat of war.

We seek a society with equity and justice for all.

We seek a community where every person's potential may be fulfilled.

We seek an earth restored.

Issues with which FCNL is currently concerned include:

- Strategy to end the war in Afghanistan
- Investment in Peace: In 2009 33% of our tax dollars went to fund the Pentagon and related agencies. Just 1% was spent on tools to prevent war: diplomacy, development, and international cooperation
- Fixing the broken immigration system
- Honoring promises for Native Americans
- Cutting greenhouse gas pollution
- Reducing the risk of nuclear weapons
- Shifting money from the military budget to advance the peaceful prevention of deadly conflict through diplomacy and to better meet human needs for education, health care, the environment, infrastructure, and help for the most vulnerable in the U.S. and the world.
