#### First Month 8, 2012 Summary of Minutes of Meeting for Worship with Attention to Business

- Opening worship with 20 persons present.
- Approval of Agenda: The agenda was APPROVED
- Minutes of the Twelfth Month: APPROVED.
- Action Items:
  - Cindi Goslee's request for transfer of membership to West Richmond Friends' Meeting. Frank read the letter. Ministry & Counsel has approved the transfer. The meeting APPROVED with our expressions of gratitude for Cindi's years of service to our meeting.
  - Roland Kreager's request of transfer of membership to West Richmond Friends' Meeting. Frank read
    the letter. Ministry & Counsel has approved the transfer. The meeting APPROVED with our expressions
    of gratitude for Roland's years of service to our meeting.
  - Moving ahead with the Quaker Quest process. There were questions about the involvement needed and the money it might cost. Is the meeting ready to move forward? Tim Leonard explained that a core group would be formed that would be making decisions about moving forward. Matching funds would be available from FGC. Cost would be about \$1200 - \$2000. It was explained that the process would help us develop our beliefs and help us find our voice to express those beliefs. Do we want to grow? It is a huge question. The item was referred back to Ministry & Counsel for further discernment and a determination on how to move forward.
  - Appointment of Barbara Wood and Richard House as Cannon Fund Trustees, and Mary Anne Curtiss, as Treasurer, to withdraw funds from the Pax World Fund.
- Treasurer's Report: We are at the bank balance/annual budget ratio of 10%. We met the budget for 2011. The question is still open as to whether we have paid for or still owe FGC for the flights of their personnel for our Quaker Quest workshop. The treasurer's report was ACCEPTED, with gratitude.

#### • Committee Reports:

- Peace & Social Concerns: Marlane Souder reported that they will be planning the 2012 program.
- Ministry & Counsel: Tim Leonard reported that they will be doing the annual review of the work of the caretakers. They will also be dealing with the problem of latecomers disrupting the meeting for worship.
- House & Grounds: Eric Wolff announced the next meeting and the 1/21work day. John Sneigocki reported that gas usage was down by 70% and electric usage by 57%.
- FUN: Kate Anthony reported that they will be investigating solar power for the electricity for the composting toilet. They are also looking into insulating the meetinghouse. They would especially like to minute our appreciation for the caretakers' careful stewardship or our resources
- o Community Committee: Tom Zalla announced that the winner of the First Day recipe contest is the vegetarian chili. The recipe will be published in the newsletter.
- Newsletter: Mary Anne Curtiss asked that if we are going to be seeking permission to publish drawings in the newsletter, what about photographs?
- Sara Hofmann reported that Stewardship is continuing to meet.

Summary of DRAFT of Minutes from Meeting for Worship with Attention to Business, Second Month 12, 2012

- Opening worship with 14 persons present.
- Minutes of the First Month: APPROVED.
- Items from The Clerk's Table:
  - Received a letter of thanks from FGC for our contribution.
  - o Received a letter of thanks from the Quaker Inner City Secondary Education Fund for our contribution.

#### Action Items:

- Shannon Isaacs' request for adult membership was APPROVED with pleasure, noting that she has been very active in the meeting and with FGC. The welcoming committee will be the meeting as a whole, with Sue Brungs convening.
- O Marjorie McKelvey Isaacs presented the Stewardship Committee's request for permission for the Treasurer to share with the Stewardship Committee how much individuals contributed last year to assist in their fund raising activities. After discussion, the request was APPROVED, with Stewardship charged with the responsibility to develop the procedure by which individuals can opt out of either having their contributions shared with the Committee, or being contacted by the Committee concerning contributions.
- Bill Cahalan presented FUN Committee's request that the meeting consider sponsoring the publication of the CORVA local food guide, which includes a \$250 contributions. The meeting APPROVED the request, with the money to be taken out of the FUN Fund, which money should be replaced by individual contributions to the FUN Fund.
- **Treasurer's Report:** In the absence of the Treasurer, the report was ACCEPTED, after one question about whether any funds were going to the Building Reserve Fund at the end of 2011.

- Peace & Social Concerns: Marjorie McKelvey Isaacs reporting. They will be setting up a threshing session concerning the meeting's feedback to FCNL on their legislative priorities for lobbying in the next 2-year session of Congress.
- Ministry & Counsel: Tim Leonard reported that they will be setting up a Clearness Committee on membership for Pam Richards, and will be looking at whether the meeting is interested in growth and whether we want to move ahead with the Quaker Quest process.
- House & Grounds: Eric Wolff announced that the Committee has finished the big job of painting in the basement. They are talking about the possibility of tapping into solar energy.
- Religious Development: Lisa Cayard reported that the Committee is talking about evening programs for the younger children and possible even sleep-overs. The teens went to" The Quake that Rocked the Midwest" in Chicago, and are planning more weekends coming up.
- Adult Education: They have been giving input to the Quaker Quest planning process. The Committee also plans to do another "Fundamentals of Quakerism" series on March 10 and April 7.
- FUN: Kate Anthony reported that they will be planning more woods restoration in the spring and a "Walk in The Woods". They are still looking at solar power.

# **Calling all Friends: FUN Fund Forever**

At Meeting for Worship with Attention to Business on 2/11/12, Friends agreed to buy an ad in the 5<sup>th</sup> edition of the Central Ohio River Valley (CORV) Local Food Guide. The ad would promote Community Friends Meeting and support the guide both. "CORV" was initiated by Deborah Jordan largely through a grant from the Cannon Fund in 2008; the history of the Cannon Fund's connection to the land and initiating the publication will be in the guide this year. There will be 40 to 45,000 copies printed, the majority being distributed as an insert in City Beat in April.

Friends then decided how to fund the \$250 for the ad from our budget. Thanks to the annual Friends in Unity with Nature (FUN) committee plant sale (through the efforts of Kate Anthony's Friendly Garden Nursery and others who contribute plants), we have set aside a fund of \$360 to use for future sustainability projects like the woodland restoration work. Friends agreed that the money would temporarily come from this fund. This seems appropriate since FUN has also promoted local food and is supportive of "CORV."

This is where we call on Friends to help replenish this fund for the upcoming woodland restoration work. Donations can be given to our Treasurer. Help the gift keep moving as we "strive for sustainable lives in order that all living beings, as well as those yet to be born, might flourish." ### **FCNL LOBBY**

Last December Community Friends hosted Matt Southworth, staffer at FCNL, for a day-long training on lobbying. The agenda included a role play of planning a lobbying visit. Mary Anne Curtiss, Eugenia Mills, Pamela Richards and I decided that we would keep it real: this would be the start of the process of cultivating a real relationship with at least one of our legislators. We followed up that first meeting with a few more, and were joined along the way by Tim Leonard and Peter Seidel who were similarly inspired to really follow through on what the workshop had set in motion. We cast about for a focus: what would we be asking of our legislator? Way opened: we learned that FCNL had chosen, for a main lobbying focus this year, to urge, persuade, and convince Congress by all means possible to hold to the federally mandated \$1 trillion cuts in projected Pentagon spending through 2021. (After the budget super committee failed last year to come to an agreement, and the defense contractors are lobbying hard to weaken or overturn these spending caps mandated by the 2011 Budget Control Act.) An information laden FCNL conference call led by FCNL veteran Ruth Flower presented itself at just the right time to educate and focus our group.

By our third meeting together, we had secured scheduled times with both Ohio Senators; Tim and Peter would meet with one of Portman's aides on January 30th, and our group of four with Sen. Brown's staff on the 31st. Both meetings went well. We talked about the detrimental effects of the out-of-control military spending on our own lives – such as Eugenia's concern with state funding cuts at Quaker Heights, Mary Anne's perspective as a physician working with the indigent. We shared from our own experience, and provided materials that FCNL has created, to help bolster our ask



that the Senators keep the military cuts intact. It was clear that the staffer who met with us was learning: she seemed eager to receive our handouts from FCNL.

The folks at FCNL project that this matter of the military cuts (we are calling it a peace dividend) will not be resolved before the November 2012 election, so we let the staffers know that we would like to see our meeting as the start of an ongoing dialogue. Our Friends in Washington believe that we are at a critical time, possibly an unprecedented opportunity for scaling back and reprioritizing our military behemoth. Their work on the Hill is supported by grassroots lobbying efforts, and we'd like to encourage other Friends and those among the Cincinnati Peace

Churches to join us in putting another drop in the bucket.

This month's most requested recipe was for Monster Cookies. In respect to Quaker concerns de-emphasizing the individual we have agreed that the recipe should not mention the cook by name.

This makes a LARGE batch but you can ½ or even ¼ the recipe if you didn't want to make so many cookies.

#### **Monster Cookies**

12 eggs 4 c. white sugar
2 lb. brown sugar 2 Tbsp. vanilla
1 Tbsp. white syrup 8 tsp. baking soda
1 lb. butter 3 lb. peanut butter
18 c. oatmeal 1 lb. M&M's candies

1 lb. chocolate chips

Use ice cream scoop to drop cookies on the cookie sheet. Bake 12 minutes at 350. Makes 100 to 120 cookies. Takes a very large bowl to mix, like a dishpan. (No flour: dough can be frozen)
