Twelfth Query from OVYM Book of Discipline, 1978: Stewardship; Business Relations

November 9, 2014 Business Meeting Summary, prepared by Paul Buckley, Recording Clerk

The meeting opened with fifteen Friends present. During a period of worship, the presiding clerk read from the website of New York Yearly Meeting on how to open ourselves to creative action through shared worship and a willingness to accept disagreements.

The **Treasurer** reported that the formula for calculating the percent of the total budget that is in the General Fund at the end of the month has been modified to include our commitment to putting \$5000 into the Building Reserve Fund each year. The budget seems to be pretty much on target for the year thanks to the contributions received thus far. More will be needed.

It is time to begin putting together next year's budget. Clerks of committees are asked to send their anticipated expenses to the treasurer.

The **Adult Religious Education Committee** reported that three of the in reach groups have already met and one has been placed on hold for the time being.

The **Victory of Light** is coming up this November 22 and 23 at the Sharonville Convention Center. Sign-up sheets will be circulated for those who are willing to be our representatives there.

The ARE committee is considering a new inter-meeting event like last August's "Exploring Quaker Diversity." They are inviting all Friends to come to the December committee meeting to discuss the spiritual needs of the meeting and determine a topic. The meeting will be on December 7 at 8:45AM.

House & Grounds Committee reported that "lots of projects" were completed on the workday in October. Additional tree work is scheduled for later this year.

The **Friends in Unity with Nature Committee** discussed holding a workshop on how to divest from fossil fuels. Local churches, colleges, environmental groups, government reps, and interested individuals would be invited.

The first-floor toilet has been replaced with an ultra-low, dual-flush model. The handles will be color-coded with a sign to clarify how to use the two flush levers.

The second floor composting toilet has been cleaned out by FUN committee. The manufacturer, Sun Mar, provided instructions on how to set up a drain for excess liquid to go into the sewer so it will not flood onto the floor. Committee members are evaluating what the composting toilet bathroom needs to look refreshed, including paint, and fresh versions of educational materials about composting etc.

A work day on the composting toilet and removing vines in the woods will be on November 29 starting at 10AM.

The FUN committee is supporting a protest of mountaintop removal coal mining that will be held at the Clifton branch of PNC Bank on the morning of Saturday, December 6. Contact a committee member, if you are interested.

Ministry & Counsel Committee reported the cost of the fall Renewal, including rent of the facilities at Quaker Knoll and meals was \$541. After \$430 in contributions towards these expenses from 19 participants, only \$111 came out of the committee budget.

Quakerism 101 classes started on Saturday, November 1.

The committee sent letters to youth members, inviting them to consider requesting adult membership. They are also contacting some regular attenders to encourage them to consider membership.

Several inactive members have been contacted to wish them well and ask about their intentions for continued involvement in the meeting. In response, one member responded that he has found a new faith community. The committee recommended removing his name from membership. **This was approved.**

As usual, **Religious Development Committee** will help the children put on a Christmas play. It is scheduled to be presented after meeting for worship on December 21. Practice will start after Thanksgiving.

Four of our intermediate Friends have contributed art work that will be displayed under the virtual quilt on the Quaker Heights website.

At its meeting on November 5, the **Peace & Social Concerns Committee** reviewed the content and timing of their second hour in February and put the spring presentation/movie night on the meeting calendar. They also had an informative and involving discussion regarding the relationship between for-profit prisons and the military and police killings of unarmed citizens.

The committee decided to reinvigorate the process for creating an "issues of concern" page.

Two committee members attended AMOS's public meeting for launching the Exodus Campaign, a movement of the church and faith community whose goal is to end childhood poverty in Greater Cincinnati.

November, 2014 Business Meeting Summary, Continued

The **Metropolitan Area Religious Coalition of Cincinnati** fall planning conference will be held November 18th. At least five people will be going from Community and Cincinnati Friends Meetings.

P&SC discussed the **Earth Quaker Action Team** action at the Clifton PNC Bank. There will be twenty groups in at least seven states doing coordinated actions at PNC banks on December 6. The purpose of the protests is to put pressure on PNC bank to stop making loans to companies that do mountaintop-removal coal mining.

The **Centering Prayer** group at Lebanon Correctional Institution is going well and will be extended indefinitely. More men will be integrated into the group after the first of the year.

Four local Friends will be attending the **Friends Committee on National Legislation** annual meeting November 20-23.

The **Tender Mercies** meals continue to go well thanks to the ongoing contributions of meeting members.

A short survey on **Joint Quarterly Meeting** has been sent out by email. Friends are encouraged to complete it.

It was noted that we continue to support the **Free Store**.

Friends from El Salvador made a presentation on current conditions there on October 22.

MARCC (Metropolitan Area Religious Coalition of Cincinnati) Fall Planning Conference

The Planning Conference was held to select issues for MARCC 2015 Concerns.

FIVE Concerns were presented

- Community police relations/ justice reform
- Economic recovery/ income disparity and employment
- Homelessness/affordable housing
- Human Service/hunger/ Medicaid expansion
- Interfaith Dialogue/ Human Rights

The five representing the Religious Society of Friends were unanimous in selecting Community police relations/justice reform.

Each of the 17 Judicatories of which the Religious Society of Friends is one got one vote

The results were:

1. Economic recovery/ income disparity and employment
2. Interfaith dialogue/ Human rights
3. Human Services/Hunger/Medicaid Expansion
4. Community Police Relations/Justice Reform
5. Homelessness/affordable housing

JUSTICE FOR KEITH La MAR

Keith LaMar has been imprisoned on Ohio's death row since 1995 for his alleged role during the "Lucasville Uprising" of 1993. He was falsely accused of having murdered prisoners and having "led a death squad." No physical evidence connects Keith to the murders that took place when the prison at Lucasville was in uprising. The verdict is based on (forced) snitch testimony.

Keith wrote a book called *Condemned*, in 2004, to highlight his life and the truth about what happened. This book [Condemned: The Whole Story](#) is now published.

From his Facebook Page: Justice for Keith LaMar

The day (Dec. 2) is upon us at last. Today, we descend upon the Sixth Circuit Court of Appeals in Cincinnati and stand in solidarity with Keith LaMar as his final appeal is made. Supporters, can we pause for a moment together and give thanks for the many blessings we have shared in coming to know one another in this fight, and particularly give celebration for how Keith has been able to lend his voice to this narrative in unprecedented ways this past year. Today, people from all walks of life will stand up in unity for this man who deserves, like anyone else, for the truth of his innocence to be heard. Today we pray that everyone will do their due diligence toward a just end: the prosecutors, the defense attorneys, and the three justices who will eventually determine what comes next for Keith. We call out to the ancestors who know Keith's struggle so very well and ask for their guidance. We pray for Keith himself as he awaits the outcome from a solitary confinement cell in Youngstown, now 21 years into this madness. We ask God to guide and direct this day that all our love for Keith and commitment to righting this wrong culminates with a force that permeates the universe; we await a just response. Today we call out for Justice for Keith LaMar, standing on the truth that love is the only freedom...

We now await the decision of the judges.
