## Seventh Query from OVYM Book of Discipline, 1978: Religious Fellowship

Are you active in advancing the religious principles of our society and in applying the social and political implications of those principles?

## June 8, 2014 Business Meeting Summary

The meeting opened with a period of worship during which the clerk read a summary of Quaker business process by Terry Wallace from "Misunderstanding Quaker Faith and Practice," *Friends Journal*, January 2007. An **Ohio Valley Yearly Meeting Budget Request** was considered. Our contribution to support the work of OVYM for the current fiscal year is due at this time. The amount was more than we expected, but we **approved** meeting the commitment as soon as we can, trusting the Spirit to lead people to target the contribution box. OVYM has requested a slightly larger donation for the year starting July 1. That increase to \$8880 was **approved**.

**Religious Development Committee** reported that there is a new summer child care provider, Katelyn Buckman, and we're started the summer program.

The **Adult Religious Education Committee** held an organizational meeting on June 1. The committee decided to meet at 9AM on the first Sunday of each month.

In addition, one email was received from an individual who was unable to participate in an Inreach Group due to a lack of transportation and who asked that we consider how to help all meeting members to participate.

## **June 8, 2014 Business Meeting Summary, continued**

The August 16<sup>th</sup>, "Exploring Quaker Diversity" event is shaping up. The presenters are: Dale Graves, current Presiding Clerk of Western Yearly Meeting (FUM), Carole Spencer, a recorded minister in Friends Church-Northwest (Evangelical Friends International) and Associate Professor of Christian Spirituality at the Earlham School of Religion, Fran Tabor, a well-known member of the Ohio Yearly Meeting (Conservative), and Dan Coppock, a young Adult Friend who grew up in Eastern Hills Meeting and is currently the Maintenance Director at Olney Friends School.

**Stewardship** and the **Friends in Unity with Nature Committees** are planning a June 22<sup>nd</sup> threshing session on issues related to divesting from fossil fuels.

The **Peace & Social Concerns Committee** believes the "The New Jim Crow" book discussion and the movie, "Broken on All Sides," were well received. Participants were engaged and interested; the discussions were earnest and raised awareness about the character and effects of the criminal justice system.

A page is being created for the meeting's web site to highlight the committee's issues of concern and to provide a means for taking action. A mock-up of the page has been reviewed by them.

The committee recommended that the meeting consider sponsoring a Quaker Volunteer Service House in Cincinnati. They feel this request follows where Life has been rising in the meeting. They noted that supporting a QVS house would require a significant commitment from the meeting.

Foundation questions considered included: Is there interest and do we want to do this? Should we reach out to other meetings? Moving forward, it was determined that inclusion of other meetings should take place. The business meeting **approved** taking time to answer the queries and exploring the idea.

**Community Committee** is in the process of planning another Quakerfest on October 5<sup>th</sup>.

**Ministry & Counsel Committee** is planning a series of Quakerism 101 classes in the fall for newcomers and others who are interested. They noted Deborah Fisch from FGC's Traveling Ministers Program will be leading a workshop at Joint Quarterly Meeting on nurturing ministry.

The Meeting Renewal will be held September 6 at Quaker Knoll. The committee is planning a more open day of reflection and worship sharing, without a paid facilitator.

In order to keep the library open for those who would like to use it after the rise of meeting, the member of M&C will be available on the window seat of the staircase landing.

In response to concerns about Second Hours getting later and later in the day, they recommend that the meeting set the time for Second Hour discussions from 11:45 to 12:45. **Approved**. They will also request that non-meeting announcements be limited to one sentence to keep the end of meeting time to a more reasonable length. Byron Branson's Memorial Minute was read, shortened slightly, and **approved**.

**House and Grounds Committee** reviewed a list of ongoing projects.

The **Web Clerk** reported a noticeable amount of new information being shared on the website and encouraged further there. He reminded the meeting that anyone can post to the website.

The Ohio Valley Yearly Meeting annual sessions are planned and registration materials are in the *Quill*. The idea of scheduling future sessions a week earlier in the year will be discussed at the sessions.

The yearly meeting is looking for a middle youth coordinator (job description available).

The teen overnight will be held at Fall Creek Meeting. This year's teen service trip will be to Philadelphia and to Costa Rica next year. The teens will be making a financial request for the Costa Rica trip.

The charge for the tour (about 1 1/2 hours) is \$2 for adults and \$1 for children (children under 6 are free).


